A glitch in the app was making entering of dates inconvenient, however it is working through the computer website. Jody is working to manually fix those incorrect because of the app. About 400 birthdates are still missing from the league at this point.

Past President- Lori Cook

Lori checked with Louisville Stoneware regarding mugs for end of year awards. Mugs are \$25 per mug, and a fee of \$75 is charged to change the stamp used to print each division when putting for example *2023-24 A Division Winner*. Lori said a rough estimate of 20 players per winning team would mean 180 winner mugs, along with the stamp fee it would be about \$5,175 just for winners. Louisville Stoneware said they might be able to adjust the stamping fee, she said. They no longer make the second place smaller mug. The present budget for the year end awards is \$3,500, last season \$2,457 total was spent for awards for winners and runners-up.

Board members discussed the awards. Treasurer Cynthia Vogt said the board has enough in reserves that it would be able to increase the budget for awards if needed. However, she

encouraged the board to be mindful of trying to keep the budget balanced with the same amount coming in as going out. The board will revisit this before the end of the year.

Mindy Terrell suggested the board consider putting savings into a money market to make better earnings. Cynthia Vogt said she would check to see what Stockyard offers.

Hannah shared a draft of Sponsorship levels for businesses. This was a result of having been contacted by Deka Lashes.
